LLES is a local campaigning group which raises awareness about the effects of climate change on our environment and encourages people both to save energy and to convert to renewable, non-polluting energy sources wherever possible.

LLES is a charity registered as a limited company, a member of the *Powys Environmental Partnership* and *Community Action for Energy* (CAfE) which is part of the *Energy Saving Trust*.

What does LLES do?

LLES holds public meetings about climate change and energy issues with expert speakers and plenty of opportunity for informed discussion afterwards. It helps individuals to save energy in the home, gives advice and information about renewable energy and employ a development officer who is currently assessing the town's energy use. LLES is also planning to set up a community owned electricity generating company in the near future.
